Active Membership:

- Chiefs of Police
- Sheriffs
- Directors of Public Safety
- Superintendents
- Commissioners
- Assistant Chiefs of Police
- Deputy Chiefs of Police
- Chief Executive Officers
- Division Heads of Railroad Police
- Chiefs of Campus Police
- Rank of Lieutenant and above

Active Under 10: Agencies - less than 10 officers

- Same as above, for agencies with 10 or fewer officers.

Second Active: Dues Discount

- Must have at least one current active member within the department
- Lieutenant and above
- Command College Grad – Lieutenant or above

Third Active: Dues Discount

- Must have at least two current active members within the department
- Sergeant and above
- Command College Grad – Sergeant or above

Police Clerks:

- Police clerks or records clerks -Non-Voting

Retired Active:

- A person may apply for Retired Active Membership if he or she has been a member of the MPCA for at least ten (10) years and is retired from active service

Supportive:

- Any officer or individual who has trained or possesses experience or are educators in police science or administration - **Non-Voting**
- Any officer or individual who doesn't fall in the above categories; or any individual who is supportive of the objectives and purposes of the MPCA – **Non-Voting**

SRO Membership:

- This membership is for School Resource Officers in the state of Missouri. This is level of membership is a **non-voting member of MPCA** but can vote at the MSRO committee meetings.
*** Payment for this membership level is paid to the order of MSRO**

Life Member:

- A retired Chief of Police who has also previously served as President of the Missouri Police Chiefs Association.

D.A.R.E.:

- Certified D.A.R.E. officer who are active D.A.R.E. instructors.
